RF Code End User License Agreement

This End-User License Agreement ("Agreement") is a legal agreement between you (as an individual or, if applicable, the legal entity on whose behalf you are acting) as the "Licensee" of the Software ("Licensee") and RF Code, Inc. ("RF Code"). BY USING THE SOFTWARE, YOU ACCEPT THESE TERMS. IF YOU DO NOT ACCEPT THEM, DO NOT USE THE SOFTWARE.

Your acceptance means you (a) accept this Agreement and agree that you are legally bound by its terms; and (b) represent and warrant that: (i) you are of legal age to enter into a binding agreement; and (ii) if Licensee is a corporation, governmental organization, or other legal entity, you have the right, power, and authority to enter into this Agreement on behalf of Licensee and bind Licensee to its terms. The Software is licensed (not sold) for use subject to Licensee's acceptance of and compliance with the terms of this Agreement. If Licensee does not agree to the terms of this Agreement, RF Code will not and does not license the Software to Licensee and you must not install or use the Software or Documentation.

Notwithstanding anything to the contrary in this agreement or your or Licensee's acceptance of the terms and conditions of this Agreement, no license is granted (whether expressly, by implication or otherwise) under this Agreement, and this Agreement expressly excludes any right, concerning any Software that Licensee did not acquire lawfully or that is not a legitimate, authorized copy of the Software.

1. Definitions

For purposes of this Agreement, the following terms have the following meanings:

"Authorized Users" means the following individual persons authorized to use the Software (as later defined) pursuant to the license granted under this Agreement: (a) if Licensee is an individual, you alone are an Authorized User, and (b) if Licensee is an entity, Licensee's employees and Licensee's contractors acting on Licensee's behalf are Authorized Users.

"Documentation" means user manuals, technical manuals, and any other materials provided by RF Code with the Software or Hardware, in printed, electronic, or other form, that describe the installation, operation, use, or technical specifications of the Software or Hardware.

"Software" means the RF Code software and any related firmware provided by RF Code to Licensee pursuant to an Order Form, and includes any upgrades, updates, bug fixes, and modified versions that may be provided to Licensee by RF Code in its sole discretion ("Upgrades").

2. License Grant

2.1 Scope of License.

Subject to and conditioned upon Licensee's strict compliance with all terms of this Agreement, RF Code grants to Licensee a personal, non-transferable, non-sublicensable, non-exclusive limited license during the term of this Agreement to, solely by and through its Authorized Users, do the following:

- (a) use the Documentation and the Software (in object code form only) in accordance with the Documentation, download and install the Software locally or use the firmware installed on RF Code hardware ("Hardware") either located at Licensee's site or hosted by a commercial hosting site or facility where Licensee's equipment resides or is stored, solely for Licensee's internal use and provided that Licensee has paid the applicable license fees;
- (b) make a reasonable number of copies of the Software solely for backup or archival purposes;

- (c) use and run the Software as properly installed in accordance with this Agreement and the Documentation, solely as set forth in this Agreement and the Documentation; and
- (d) download or otherwise make a reasonable number of copies of the Documentation and use that Documentation, in each case, solely in support of its licensed use of the Software in accordance with this Agreement.

2.2 Limitations.

All copies of the Software and Documentation will be: (i) the exclusive property of RF Code; (ii) subject to the terms and conditions of this Agreement; and (iii) must include all trademark, copyright, patent and other intellectual property rights notices contained in the original.

2.3 Ownership.

The Software and Documentation are owned by RF Code and its licensors and are protected by copyright and other laws of the United States and other jurisdictions.

2.4 Third-Party Licenses.

- (a) The Software and Documentation may include software, content, data, or other materials, including related documentation, that are owned by individuals other than RF Code and that are provided to Licensee on terms that are in addition to and/or different from those contained in this Agreement ("Third-Party Licenses"). Licensee is responsible for complying with all Third-Party Licenses. A list of certain of these Third-Party Licenses can be found at www.rfcode.com/thirdpartyterms and the applicable Third-Party Licenses are accessible via links on that site. Licensee is bound by and will comply with all Third-Party Licenses. Any breach by Licensee or any of its Authorized Users of any Third-Party License is also a breach of this Agreement.
- (b) Licensee may need to have Java Runtime Environment (JRE) program application in order to properly use the Software. Licensee may obtain a license for the JRE program from Oracle Corporation. Licensee may be subject to terms and conditions from Oracle Corporation that are different or additional to the terms contained in this Agreement.

2.5 License Restrictions.

(a) Licensee agrees that Licensee will not: (a) use the Software or Documentation except as expressly permitted under the terms of this Agreement; (b) reverse engineer, decompile, disassemble, modify, merge, translate, or attempt to discover either the layout of the Hardware or the source code of the Software, or create derivative works; (c) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer or otherwise provide any access to or use of the Software or any features or functionality of the Software, for any reason, to any other person or entity, including any subcontractor, independent contractor, affiliate or service provider of Licensee, whether or not over a network and whether or not on a hosted basis. including in connection with the internet, web hosting, wide area network (WAN), virtual private network (VPN), virtualization, time-sharing, service bureau, software as a service, cloud or other technology or service; (d) install the Software in any way which would permit or authorize the Software to be used in connection with more than the maximum number of items of Hardware purchased for use with the Software; (e) transfer, assign, sublicense, sell or otherwise convey any of Licensee's rights to or license in the Software or Documentation or under this Agreement without the express written approval of RF Code; (f) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices provided on or with the Software or Documentation, including any copy; or (g) use the Software or Documentation in, or in association with, the design, construction, maintenance, or operation of any hazardous environments or systems, including: (i) power generation systems; (ii) aircraft navigation or communication systems, air traffic control systems or any other transport management systems; (iii) safety-critical applications, including medical or life-support systems, vehicle operation applications or any police, fire, or other safety response systems; and (iv) military or aerospace applications, weapons systems, or environments.

3. RF Code's Proprietary and Intellectual Property Rights

All right, title, and interest, including all Intellectual Property Rights, in and to the Hardware and Software are and will remain the sole and exclusive property of RF Code and its suppliers, if any, whether the Hardware and Software are separate or combined with any other products. RF Code's rights under this Section will include, but not be limited to: (a) all hardware, firmware, software, and copies thereof, in whole and in part; and (b) all modifications to, and derivative works based upon, the Hardware or Software. For purposes herein, "Intellectual Property Rights" means patent rights (including patent applications and disclosures), copyrights (including, but not limited to, rights in audio visual works and moral rights), trade secret rights, rights of priority and any other intellectual property right recognized in any country or jurisdiction in the world.

4. Audit Rights

Licensee will, after reasonable prior written notice from RF Code, provide RF Code and its agents reasonable access to Licensee's premises, records, and/or personnel so that RF Code may audit and confirm that Licensee complies with the License Agreement.

5. Maintenance, Support, and Upgrades

RF Code or an RF Code Authorized Reseller may provide Licensee with maintenance and support services, but such maintenance and support services must be separately purchased by Licensee under a separate maintenance and support services agreement, unless otherwise agreed by the parties.

6. Responsibility for Use of Software

Licensee is responsible and liable for all uses of the Software and Documentation through access to the Software or Documentation provided by Licensee, directly or indirectly. Specifically, and without limiting the generality of the foregoing, Licensee is responsible and liable for all actions and failures to take required actions with respect to the Software and Documentation by its Authorized Users or by any other Person to whom Licensee or an Authorized User may provide access to or use of the Software or Documentation, whether that access or use is permitted by or in violation of this Agreement.

7. Security Features

The Software may contain technological copy protection or other security features designed to prevent unauthorized use of the Software, including features to protect against any use of the Software that is prohibited under Section 2.5. Licensee will not, and will not attempt to, remove, disable, circumvent, or otherwise create or implement any workaround to, any of those copy protection or security features.

8. Term and Termination

- 8.1 Term and Termination.
- (a) The term of this Agreement commences on the date Licensee first uses the Software and continues until terminated by either party in accordance with this Agreement.
- (b) Licensee may terminate this Agreement by ceasing to use and destroying all copies of the Software and Documentation.
- (c) RF Code may terminate this Agreement, effective upon written notice to Licensee, if Licensee breaches this Agreement and that breach: (i) is incapable of cure; or (ii) being capable of cure, remains uncured 10 days after RF Code provides written notice of the breach.
- (d) RF Code may terminate this Agreement, effective immediately, if Licensee files, or Licensee has filed against Licensee, a petition for voluntary or involuntary bankruptcy or pursuant to any other insolvency law, makes or seeks to make a general

assignment for the benefit of its creditors or applies for, or consents to, the appointment of a trustee, receiver or custodian for a substantial part of its property.

8.2 Effect of Termination.

Upon the termination of this Agreement: (a) all rights and licenses granted by RF Code to Licensee under this Agreement will terminate; and (b) Licensee must immediately cease use of the Software, remove the Software from all computers or servers, and return all copies of the Software and Documentation to RF Code, or, at RF Code's option, destroy all copies of the Software in any form.

9. Warranty and Disclaimer of Warranties

9.1 Limited Software Warranty.

RF Code represents and warrants that the Software will operate in all material respects in accordance with the applicable Documentation for a period of 12 months following shipment of the Software if (a) the Software is installed, implemented, and operated in accordance with the Documentation and any other written instructions supplied by RF Code or the RF Code Authorized Reseller; (b) Licensee notifies RF Code or the RF Code Authorized Reseller in writing of any error within 10 days of the appearance thereof and include sufficient example programs as may be necessary to demonstrate and reproduce the error; (c) Licensee has not, or a third party has not, modified the Software or combined the Software with equipment or software other than that which is consistent with the Documentation; and (d) Licensee has promptly and properly installed any and all bug fixes, maintenance modifications, upgrades and updates made available by RF Code to Licensee.

9.2 Exclusive Remedies.

To the fullest extent allowed under applicable law, for any breach of the limited warranties described Licensee's sole and exclusive remedy and RF Code's entire liability for any non-conformities to the express limited warranties under Section 9.1 above will be as follows: RF Code will correct or replace the non-conforming Software, which may include the delivery of a commercially reasonable workaround for the non-conformity; or if RF Code determines that repair or replacement of the applicable Software is not commercially practicable, then terminate this Agreement with respect to the non-conforming Software and provide a pro rata refund of the fees Licensee paid attributable to the non-conforming portion of the Software based on a 3 year amortization schedule.

9.3 Disclaimer of Warranties.

EXCEPT FOR THE LIMITED WARRANTIES DESCRIBED IN SECTIONS 9.1 AND 9.2, RF CODE MAKES NO OTHER EXPRESS OR IMPLIED WARRANTIES WITH RESPECT TO THE SOFTWARE, DOCUMENTATION, HARDWARE, OR OTHERWISE AND SPECIFICALLY DISCLAIMS ALL IMPLIED AND STATUTORY WARRANTIES INCLUDING THE IMPLIED WARRANTIES OF NON-INFRINGEMENT OF THIRD PARTY RIGHTS, MERCHANTABILITY, SATISFACTORY QUALITY, AND FITNESS FOR A PARTICULAR PURPOSE AS WELL AS ANY WARRANTIES ARISING FROM A COURSE OF DEALING, USAGE OR TRADE PRACTICE. IF SUCH DISCLAIMER IS NOT PERMITTED BY LAW, THE DURATION OF ANY SUCH IMPLIED WARRANTIES IS LIMITED TO 90 DAYS FROM THE DATE OF DELIVERY. IN ADDITION, RF CODE DOES NOT WARRANT THAT THE SOFTWARE, DOCUMENTATION OR HARDWARE WILL SATISFY LICENSEE'S REQUIREMENTS, IS WITHOUT DEFECT OR ERROR, OR THAT THE OPERATION OF THE SOFTWARE OR HARDWARE WILL BE UNINTERRUPTED. BECAUSE IT MAY NOT BE POSSIBLE FOR RF CODE TO KNOW THE EXACT PURPOSES FOR WHICH LICENSEE ACQUIRED THE SOFTWARE OR HARDWARE, LICENSEE ASSUMES FULL RESPONSIBILITY AND FOR ITS INSTALLATION AND USE AND THE RESULTS OF THAT USE.

No oral or written information given by RF Code, its agents, or employees shall create any additional warranty. No modification or addition to the limited warranties set forth in this Agreement is authorized unless it is set forth in writing, references this Agreement, and is signed on behalf of RF Code by a corporate officer.

This exclusion also applies to any of RF Code's subcontractors, suppliers, authorized service providers, and program developers (collectively "Suppliers"). Some jurisdictions do not allow the exclusion or limitation of warranties, so such limitation or exclusion may not apply to Licensee.

10. Limitation of Liability

IN NO EVENT WILL RF CODE OR ITS SUPPLIERS BE LIABLE TO LICENSEE FOR ANY CONSEQUENTIAL, SPECIAL, PUNITIVE, INCIDENTAL, OR INDIRECT DAMAGES OF ANY KIND ARISING OUT OF OR IN CONNECTION WITH THE USE OF OR INABILITY TO USE THE RF CODE SOFTWARE, INCLUDING LOST PROFITS, LOSSES ASSOCIATED WITH BUSINESS INTERRUPTION, LOSS OF USE OF THE SOFTWARE, LOSS OF DATA, COSTS OF RE-CREATING LOST DATA, OR COSTS OF PROCUREMENT OF SUBSTITUTE GOODS, EVEN IF RF CODE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY REMEDY. IN NO EVENT WILL RF CODE'S AGGREGATE LIABILITY FOR ANY CLAIM, WHETHER IN CONTRACT, TORT OR ANY OTHER THEORY OF LIABILITY, ARISING OUT OF THIS AGREEMENT EXCEED THE TOTAL LICENSE FEES PAYABLE BY LICENSEE FOR THE SOFTWARE AND NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY REMEDY. RF CODE'S PRICING REFLECTS THE ALLOCATION OF RISK AND LIMITATIONS ON LIABILITY CONTAINED IN THIS AGREEMENT. Some jurisdictions do not allow the exclusion or limitation of damages, so such limitation or exclusion may not apply to Licensee. The foregoing limitations will apply even if any limited remedy fails of its essential purpose.

11. Indemnification by Licensee

Licensee agrees to defend, indemnify and hold RF Code, its officers, directors, agents, representatives and employees harmless from and against any and all damages, costs, liabilities, expenses and settlement amounts incurred in connection with any suit, claim, or action by any third party arising out of use or misuse of the Software by Licensee, Licensee's officers, directors, agents, representatives or employees.

12. General Provisions

12.1 Export Compliance.

Licensee agrees to comply with all applicable laws, rules and regulations in connection with Licensee's activities under this Agreement, including but not limited to export and import laws. Licensee acknowledges that it is Licensee's responsibility to obtain any required licenses to export and re-export the Software. Licensee acknowledges that it is Licensee's responsibility to obtain any necessary licenses to import the Software if it has not been done by Licensee's RF Code Authorized RESELLER. The Software, including technical data, is subject to U.S. export control laws, including but not limited to the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other countries. Licensee further agree that none of the Software is being or will be acquired for, shipped, transferred, or re-exported, directly or indirectly, to proscribed or embargoed countries or their nationals and persons on the Table of Denial Orders, the Entity List or the List of Specifically Designated Nationals, unless specifically authorized by the U.S. Government for such purposes.

12.2 Governing Law; Forum.

The Software is protected by United States copyright laws and international treaty provisions. This Agreement will be governed by the laws of the United States and the State of Texas without regard to the conflict of laws provisions of any state or jurisdiction and will be brought exclusively in the state or federal courts located in Travis County, Texas. The United Nations Convention on Contracts for the International Sale of Goods is specifically disclaimed.

12.3 Attorneys' Fees.

If either party to this Agreement brings an action to enforce or interpret this Agreement, the prevailing party will be entitled to recover reasonable attorneys' fees and litigation costs and expenses in addition to any other appropriate relief.

12.4 Assignment.

Licensee may not assign or otherwise transfer any of Licensee's obligations or performance, this Agreement or any licenses granted or obligations set forth in this Agreement, in each case whether voluntarily, involuntarily, by operation of law, merger, a sale of all or substantially all of Licensee's assets, business reorganization or otherwise, without RF Code's prior written consent and any attempted assignment by Licensee shall be null and void. RF Code may freely assign or otherwise transfer all or any of its rights, or delegate or otherwise transfer all or any of its obligations or performance, under this Agreement without Licensee's consent. This Agreement is binding upon and inures to the benefit of the parties hereto and their respective permitted successors and assigns.

12.5 Severability.

In the event that any provision of this Agreement is found to be unenforceable, such provision will be deemed modified to the extent necessary to allow enforceability of the provision as so limited, being intended that RF Code will receive the benefit contemplated herein to the fullest extent permitted by law, and the validity and enforceability of the remaining provisions will not be affected thereby. If any material limitation or restriction on the use of the Software or Hardware under this Agreement is found to be illegal, unenforceable, or invalid, Licensee's right to use the Software and Hardware will immediately terminate.

12.6 Waiver.

Failure of either party to require performance by the other party of any provision hereof will not affect the full right to require such performance at any time thereafter; nor will the waiver by either party of a breach of any provision hereof be taken or held to be a waiver of the provision itself.

12.7 Entire Agreement.

This Agreement is the final and complete expression of the agreement between these parties regarding Licensee's use of the Software and Documentation. This Agreement supersedes, and the terms of this Agreement govern, all previous oral and written communications regarding these matters, all of which are merged into this Agreement, except that this Agreement does not supersede any prior nondisclosure or comparable agreement between the parties executed prior to this Agreement being executed, nor does it affect the validity of any separate agreements between the parties relating to professional services relating to the Software that RF Code may provide. No employee, agent, or other representative of RF Code or any vendor, reseller or other person has any authority to bind RF Code with respect to any statement, representation, warranty, or other expression unless the same is specifically set forth in this Agreement. No usage of trade or other regular practice or method of dealing between the parties will be used to modify, interpret, supplement, or alter the terms of this Agreement. This Agreement may be changed only by a written agreement signed by an authorized agent of the party against whom enforcement is sought. RF Code will not be bound by, and specifically objects to, any term, condition or other provision that is different from or in addition to this Agreement (whether or not it would materially alter this Agreement) that is proffered by Licensee in any purchase order, receipt, acceptance, confirmation, correspondence, or otherwise, unless RF Code specifically agrees to such provision in writing and signed by an authorized agent of RF Code.

12.8 U.S. Government Restricted Rights.

The Software is commercial computer software, as such term is defined in 48 C.F.R. §2.101. Accordingly, if the Licensee is the U.S. Government or any contractor therefor, Licensee will receive only those rights with respect to the Software and Documentation as are granted to all other end users under license, in accordance with (a) 48 C.F.R. §227.7201 through 48 C.F.R. §227.7204, with respect to the Department of Defense and their contractors, or (b) 48 C.F.R. §12.212, with respect to all other U.S. Government licensees and their contractors.
